- 4. The Layout promoter should open out the compound wall at the end of the roads to provide access to the neighboring lands.
- 5. The In-principle layout frame work approval is issued based on the details of area relating to the extent of site, sold and unsold plots declared by the Layout promoter/ Owners/Authorized Signatory.
- 6. The Layout Promoter /Owners/Authorized Signatory shall not encroach any Government land/ canal /road portion adjoining or passing the layout, in any manner.
- 7. The Layout Promoter /Owners/Authorized Signatory shall be responsible to tally the layout plan on the ground in all respects viz. R.S.No. of the land, extent, boundaries of the layout site, etc,.
- 8. The Layout Promoter /Owners/Authorized Signatory shall settle any legal disputes in the court of law in respect of the layout for which this in-principle layout frame work approval is issued and the Puducherry Planning Authority shall be indemnified.
- 9. The In-principle layout frame work approval issued for this layout will be revoked if the same has been obtained by furnishing any false information / statement / suppression of facts or misrepresentation of material facts in the application on which In-principle layout frame work approval has been issued.
- 10. Unsold plots in the Layout shall be sold and registered only after remittance of road development charges @ ₹.180 per sq.m of Plot area through Demand Draft drawn from any nationalized bank in favour of The Commissioner, concerned Commune Panchayat, payable at Puducherry.
- 11. The Own use portion shown as road in the northern side of the layout shall not be converted into plots and necessary access to the adjoining lands should not be objected.
- 12. Road portions, has been handed over to Commissioner, Villianur commune Panchayat, Puducerry vide reference F.No.20.1/VCP/2018-19 dated; 24.07.2018 (Gift Deed No15963 dated; 23.07.2018)
