- 6. The Layout Promoter /Owners/Authorized Signatory shall settle any legal disputes in the court of law in respect of the layout for which this in-principle layout frame work approval is issued and the Puducherry Planning Authority shall be indemnified.

- 8. Unsold plots in the Layout shall be sold and registered only after remittance of road development charges Rs.180 per sq.m of Plot area through Demand Draft drawn from any nationalized bank in favour of The Commissioner, concerned Commune Panchayat, payable at Puducherry.
- 9. Road portions, has been handed over to Commissioner, Ariyankuppam commune Panchayat, Puducherry vide letter No. 51-13/ACP/2017-18/2049 dated; 07.06.2018 (Gift Deed No.11411/2018 dated; 04.06.2018).
