- 5. - 7. Road portion has been handed over to Commissioner, Nettapakkam Commune Panchayat, Puducherry as confirmed vide reference File No.7762/Net.CP/Works/2020-21 dated 10.02.2021.
- 8. The layout has to be registered with the Puducherry Real Estate Regulatory Authority as per Section 3 of the Real Estate (Regulation and Development) Act, 2016.
