- 7. Road portion and OSR portion have been handed over to Commissioner, Villianur Commune Panchayat, Puducherry as confirmed vide reference File No.F-20-25/VCP/2021-22/JE(O)/121 dated 15.07.2021.
- 8. The layout has to be registered with the Puducherry Real Estate Regulatory Authority as per Section 3 of the Real Estate (Regulation and Development) Act, 2016.
