- 7. The conditions stipulated in the NOC issued by the Irrigation Division, PWD, Puducherry, vide letter No.3720/PW/EEI/DB/C-19/2020-21/284 dated 02.02.2021 should be strictly adhered to.
- 8. The conditions stipulated in the NOC issued by the Sub-Collector Revenue (south), Puducherry, vide letter No.7071/SCRS/B7/PPA/2020/89 dated 13.01.2021 should be strictly adhered to.
- 9. The conditions stipulated in the NOC issued by the Survey and Land Records, Puducherry, vide letter No.3670/DSLR/ADOS/2021 dated 26.10.2021 should be strictly adhered to.
