The Member Secretary apprised the committee that the Puducherry Planning Authority had accorded various building permissions from the year 2000 to 2008. The institution had constructed 36 blocks, out of which 12 blocks are unauthorized. The application submitted during 2014 was not considered by the Puducherry Planning Authority, since 5 blocks were reported to be constructed by encroaching water bodies and for the reasons detailed in the agenda. The applicant has now requested to issue building permission for the 7 buildings as above that do not fall on the encroachment of water bodies.

The committee after detailed deliberation decided that interim building permit may be issued for the above cited 7 buildings subject to the following conditions:

- (1) Applicant shall submit:
 - (i) An undertaking that the final decision of Government will be strictly abided.
 - (ii) Corrected building plan as per the actual execution at site along with necessary Fire Escape Staircase provision for the proposal shall be submitted for approval.
 - (iii) Structural Design Basis Report /Structural Soundness Certificate shall be submitted.
- (2) Clearance/NOC has to be obtained from Bahour Commune Panchayat and
- (3) Unauthorized/deviated constructions which are within the permissible limits have to be compounded as per the provision in the Puducherry Building Bye Laws and Zoning Regulations, 2012.
