- 7. The conditions stipulated by the Irrigation division, PWD vide letter No.6202/PW/EEI/DB/C-19/2022-23/3988 dated: 16.02.2023 should be strictly adhered to.
- 8. The conditions stipulated by the Electricity Department vide letter No.5307/ED/EE-R(N)/TECH/F.TO/ 2022-23 dated: 10.02.2023 should be strictly adhered to.
- 9. The layout has to be registered with the Puducherry Real Estate Regulating Authority as per the section 3 of the Real Estate (Regulation and Development) Act, 2016.
